Our training date for ePEP is scheduled for 22nd September from 3.30 to 4.30. Recommended for new designated teachers but we find that even those with experience of the electronic PEP learn something new each time! Spaces are limited to 30 to give colleagues the opportunity to ask questions but to ensure that we finish on time.

For those unable to attend the training, we would like to remind you of some of the information that would improve the quality of the PEPs, making them easier to share with young people and their carers.

Attainment – we appreciate that there are a range of interpretations around assessments for children. We therefore do give you the opportunity to put in your internal school data. This is really helpful in enabling us to determine whether we are talking about what qualification schemes are being referred to (eg Entry Level/GCSEs/SATs). We can then assess the attainment and progress data in the context of the grades.

We encourage you all to record English and Mathematics as a minimum at all key stages.

Updates on assessments for early years and SEN are expected during the term (if not done already).

SEND – whether children have an identified SEN or not, please complete the descriptor on this tab as again it enables us to make peer comparisons more easily.

SEMH – a strengths and difficulties questionnaire (SDQ) should be completed for each PEP. This tool is absolutely essential in helping you determine appropriate targets within the PEP. We will be requesting that the SDQ is uploaded to the system and this will give us the opportunity to support you in scoring the assessment.

Look out for further developments with the SDQ but we will endeavour to cover this topic at our ePEP sessions. You can also email any queries you have to the Virtual School staff member assigned to your pupils.



Extended Role of the Virtual Head

On 16th June, the Government announced more than £16 million funding to strengthen support for children with a social worker by extending the role of Virtual School Heads.

Extending the role of Virtual School Heads delivers on a key recommendation from the Government's Children in Need review.

From September 2021, Virtual School Heads will:

- be asked to be a strategic leader
- be a champion for the cohort of children with social workers
- enhance partnerships with education settings.
- will receive funding and be encouraged to engage with a research partner.

We will have further information to share with you in the coming months including the impact on your role as designated teacher and also the designated safeguarding lead.
